REFERRAL PROGRAM ADDENDUM

This Addendum to the Client Service Agreement outlines the Patriot Software Online Referral Program Terms and Conditions (“Program Terms”) and provides information on the Patriot Software Referral Program (“Program”).

Important Privacy Notice: Your friend's email address will not be used for any other marketing purposes.

1. **Eligibility.** This offer is eligible to existing direct Patriot Software (“Patriot Software”) customers with six months of continuous service (“Referrer(s)”) who share a referral link with a non-returning new customer and the new customer (“Referee(s)”) subscribes to Patriot Software during the promotional period for a minimum of 2 successful billing cycles (“Qualified Purchase”). Patriot Software reserves the right to determine in its sole discretion the eligibility of new customers and existing customers for this offer. Patriot Software further reserves the right to disqualify referrals in circumstances where we reasonably believe they were not made in good faith.
2. **Referrer Offer Terms.**
 - A. For each new Referee, the Referrer will receive a \$75 USD digital gift card if the Referee makes a Qualifying Purchase.
 - B. It may take up to 90 days to process your reward. The reward will be sent via email. The Referrer will receive the reward email after the Referee has made a Qualifying Purchase.
 - C. Digital gift cards are subject to additional terms and conditions set forth by the operator.
3. **Referee Offer Terms.** Each Referee is entitled to a \$75 USD digital gift card following the 2nd successful billing per company account with a unique and valid FEIN. This offer cannot be combined with any other Patriot Software offers. List price subject to change at any time at Patriot Software’s sole discretion. All prices are quoted without sales tax. If Referee adds or removes services, the service fees will be adjusted accordingly. No limit on the number of products ordered.

 - A. The full terms and conditions for the digital gift card are available on the digital rewards claim site. The digital gift card provider is not a sponsor of this promotion.
 - B. Patriot Software and its service providers reserve the right to modify these terms, or to change, suspend, or terminate the Program at any time and for any reason temporarily or permanently with or without notice. Patriot Software and its Program service providers reserve the right to delay, cancel, revoke, or prevent issuance of any rewards in any suspected case of fraudulent use or misuse of Patriot Software's services or this Program. Referrals and rewards are subject to verification at Patriot Software's sole discretion.

- A. No Use in Direct Business Source Identifiers. Patriot Software, PATRIOT, or other similar marks or logos, or phonetic equivalents cannot be used in your company name, product/service name or in your direct business source identifiers such as stationery, business cards, company signs, domain names or company website titles. These identifiers indicate the name of your business and, thus, the source of its products or services. In order to avoid any possible confusion with regard to the source of Patriot Software's products/services, versus your or another party's products/services, use of Patriot Software's trademarks in these source identifiers is strictly prohibited. However, Patriot Software does not object to the Referral Disclosure in Section 2, Paragraph B above being used in appropriate contexts which make clear the true nature of your relationship to Patriot Software.
7. **Miscellaneous.** Additionally, by participating in the Program, you agree that your Referral invitations will not contain any content that could be deemed by Patriot Software, in its sole judgment, to be obscene, violent or otherwise in poor taste or unlawful, or for the purpose of encouraging unlawful activities, or otherwise misuse or bring into dispute or disrepute the Patriot Software trademark, any other Patriot Software owned marks or logos, or Patriot Software's products or services.
